IX. Discussion regarding alternate truck route based on County 25th to Ash Highway.

Gary Magrino, Eric Holland, Crystal Figueroa (YMPO) and Buna met on 11/22 to discuss County 25th extension to Ash (Ave B). Project is forecasted in the YMPO 2022-2045 LONG-RANGE TRANSPORTATION PLAN UPDATE.

County 25th needs access to the West additional to the East to offer better connectivity of both ports.

X. Discussion regarding Ave D/E corridor North to Somerton from SR-195.

Yuma County has expressed that with the additional proposal of an alternative truck route to Ash Highway (Ave B) From County 25th that it makes the D/E Corridor less palatable for completion. The D/E Corridor will not only allow for an additional arterial expansion, but would also alleviate congestion on the route from County 19th and Avenue B.

XI. Discussion regarding San Luis I remodel.

Final alignment, Mexico has not yet submitted its final design and proposed outlay.

The impact of relieving traffic is essential for the City of San Luis, the discussion yielded the future need of cars and a pedestrian crossing to serve the industry that operates on both sides of the border on the east side of town. The need for that would be distinguished by GSA at a future time since the remodel project is underway. Mexico has yet to submit their final alignment to GSA, the US side of the project has been awarded to Hensel Phelps and are due to break ground in early 2023. The Cesar Chavez extension remains underway, due to a funding shortage of almost \$20million, some modifications are necessary to bring down the cost of the expansion.

A. Real Estate contract addendum extension request

Original Due Diligence period extended to 11/1/2022. Executed 8/8/2022. Second request to extend due diligence period was received 11/8, after initial extension had already expired. Buyer is asking we honor an additional extension, they are working with Core Engineering and Core has ben delayed due to staffing. I spoke with Doug, he assured me that all phase 1 documents should be completed by 12/31 to buyer.

- B. Critical Infrastructure Information within the Gary J. Magrino Industrial Development:
  - 1. Phase 4 Plat

This item was brought forth as a title objection by CPLC. Core Engineering made me aware of this week of 11/21. There is an N/S easement that runs through southern most lots to the 90 ft easement that adjoins the Border Wall.

Core Engineering will take the lead on either relocating this easement or abandoning it all together in order to not interfere with said lots.

Financial assurances to be held for a 2 year period for 10% of the development amount. 1st Year City of San Luis will honor from Yuma County on behalf of GYPA, GYPA to post 10% for second year.

Assurances for second year assurances can come from proceeds of land sales and be held in the current escrow and assurance account through National Bank of Arizona that is under the administration by the City of San Luis.

Currently \$108,000 is solidified in the NBA Escrow account that serves as assurances for the Ave D box culvert and Labrie portion of Vaughn Street. That amount is due to be released August 2023.

3. APS

\$50k coming from the Assurance Account through National Bank of Arizona, shortfall of \$30k, not due until the tail end of development. We would need to utilize the funds from the money market account to cover the shortfall until close of escrow.
