#### Trump Comments raise hopes for tariff delay for Canada and Mexico (Reuters)

WASHINGTON, Feb 26 (Reuters) - U.S. President Donald Trump on Wednesday raised hopes for another pause on steep new tariffs on imports from Mexico and Canada by saying they would take effect on April 2, about a month later than a deadline next week. A White House official, however, said the March 4 deadline for the tariffs on Mexican and Canadian goods remained in effect "as of this moment,"

pending Trump's review of Mexican and Canadian actions to secure their borders and halt the flow of the opioid fentanyl and migrants into the U.S.

#### Trump Says Canada, Mexico Tariffs Go Into Effect April 2 By Bryan Pietsch

(Bloomberg) -- "The tariffs go on, not all of them, but a lot of them," Trump says at the White House. Previous White House acts had March for imposing 25% tariffs on Canada, Mexico. President Trump says he will move forward with most of his tariff plans. Trump criticizes the flow of fentanyl that he says comes from China and flows through Canada and Mexico.

**Trump Says Canada, Mexico Tariffs Go Into Effect April 2** President Trump gave contradictory answers about his plans to enact tariffs on Canada and Mexico during a Cabinet meeting on Wednesday. He said the tariffs would be enacted on April 2, but it's not clear if he meant to give the countries more time or was referring to a separate program. Commerce Secretary Howard Lutnick also speaks.
