Meeting was called to order at 9:01 by Chairman Rosales. A quorum was confirmed by Executive Director The Pledge of Allegiance was recited.

III. Presentation

A. Introduction: Remigio (Remy) Martinez, new Director of 4Front ED.

Remigio Martinez (Remy) introduced himself to the GYPA Board. The previous evening he presented to the City of San Luis City Council, therefore some of the members of the board were acquainted with him previously. He spoke briefly about his background and his willingness to work with GYPA and other regional organizations to compliment measures that add to the regions economic prosperity.

- V. Discussion and possible action items:
 - A. Preliminary draft of the 2024/2025 fiscal year budget.

Item was discussed among the board members. The active topic of finding additional sources of income was the main topic of discussion. No action was taken Budget to be brought back in June meeting and presented to the board.

B. 2024/2025 Membership cash calls of \$50,000 to the Sovereign Nation of the Cocopahs, Yuma County, City of Yuma and City of San Luis.

Previous discussions among the board came to a consensus that the 2024/2025 cash call would be suspended to the 4 member entities.

Thus, the organization would manage its budget with interest earned from the proceeds of the land sale.

There has been no formal motion made by the board, this motion is a formality and allows the Director to issue a letter to all 4 member entities stating this fiscla years membership dues of \$50,000 have been suspended.

Motion:

Motion to provide a letter to each member entity stating that the 2024/2025 cash call has been suspended.

Motion passes unanimously.

- C. Feasibility Study for San Luis II, a partnership with the City of San Luis
 - \$400,000 contribution towards executing a feasibility study for POV's through San Luis II.
 - Board direction on approval of the partnership.
 - How would funds be distributed? Reimbursed/All at once? From what funding pool?

Motion:

Motion to allocate \$400,000 for a feasibility study for the throughput of private vehicles and pedestrians through San Luis II.

Motion passes unanimously.

- D. Right of way acquisition and design for County 25th extension to ash highway, a partnership with the City of San Luis.
 - Allocate \$120,000 to the City of San Luis to partner with YMPO and ADOT to begin the design and then follow with necessary right of way acquisition.

Motion:

Motion to allocate \$120,000 towards a preliminary design for the County 25th extension and right of way assessments. Jenny Torres noted that this type of project can take 6+ months.

Motion passed unanimously.

- E. Right of way acquisition for County 25th, Ave E east to Ave D on the south side of the road.
 - Transfer ownership of two parcels to the City of San Luis, as an act of good faith for the County 25th roadway extension project.

Item to be brought back to the board once county 25th extension study as to how much land is needed to be transferred for the appropriate amount of right

of way. Item was placed on the agenda as a discussion item, no motion was made.

Legal: GYPA bylaw changes re: creation of another organization F.

Legal representative Elizabeth Punpayuk advised the board on the matter: She noted that the 5th restated bylaws were not instated as the City of San Luis and the Cocopah Tribe had not yet signed the document for them to be enforceable. The representatives of The City of San Luis and Cocopah agreed to take this back for execution. Legal also discussed that the bylaws and articles as they stand, does not allow the GYPA to create a new organization. Mr. Jones suggested a partnership of the new organization with SWPU (Southwest Port Users). It was suggested by the Chairman that each representative would go back to their agencies and inquire about their interest, as members, separate from GYPA, in supporting a separate 501-c6 membership organization additional to the GYPA. With a possible one time "seed fund" of \$5,000 to be contributed by each entity and then create a tiered membership structure for founding and future members. The board asked legal for a briefing sheet regarding the new entity, she will provide to executive director to forward to the board. Motion to table this item to a future meeting for representatives to gather

information from their member entities.

No action was taken, item was placed as a discussion topic.

G. GYPA Physical address/office location.

> GYPA currently has a PO Box 4601 in Yuma. The last physical address listed is 748 Archibald Street San Luis, AZ (updated 08/2022) . In order to satisfy grants.gov and sam.gov registrations for grant applications, and a credit card application, GYPA needs to provide a physical address. LG Advising LLC is currently in possession of the GYPA Computer, printer and telephone line from her new location at 780 E 39th Place Suite 215 Yuma, AZ 85365.

GYPA files, archived documents, surplus office supplies and furniture are currently held in a storage facility in San Luis, AZ. Cost is \$61/month.

GYPA has had previous address changes: Initially housed at YMPO on Orange Ave to Linda's personal home in the Foothills to 198 Main Street to 748 E Archibald Street in San Luis, AZ.

Motion:

The City of San Luis has some space available for the GYPA's principal operations. City of San Luis staff will communicate options to the executive director in the near future to be utilized as a physical location for the GYPA main offices in San Luis, AZ.
